O R D E R

Whereas I am of the opinion that in the interest of General Public, it is found necessary to prevent during Christmas & New Year the use of fireworks, fire crackers and Pistol/Toy guns with rubber bullets which may lead to injuries to the Public and danger to human life by posing air and noise pollution problems which may have adverse effects on the health and well being of the people.

And whereas, I am fully satisfied that sufficient ground exists for proceeding Under Section 144 of the Code of Criminal Procedure, 1973 (Act. No. 2 of 1974)

Now, therefore, I, H. LALHMINGTHANGA, Sub-Divisional Magistrate, Saiha District, Saiha in exercise of the powers conferred on me Under Section 144 of the Code of Criminal Procedure, 1973 (Act No. 2 of 1974) do hereby order that :-

"No person within Saiha District shall stock, use, display or offer for sale any Fireworks, Fire Crackers and Toy Pistol/Guns with rubber bullets in any manner."

This order shall take immediate effect and shall remain in force for a period of 2 (two) months unless revoked earlier. Violation of this order shall entail punishment under Section 188 IPC.


