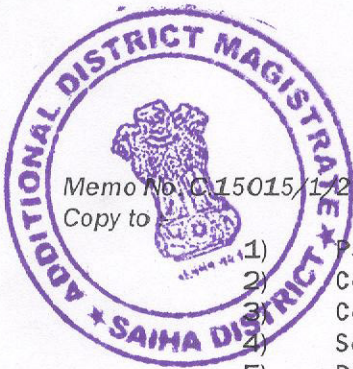

He thupek zawmlo te chu Sec. 188 IPC hmanga hrem an ni ang.


